The breeder must be presented with a certified letter from a licensed veterinarian within 30 days of finding crippling congenital severe hip dysplasia along with severe pain which, in order to be humane, would lead to euthanization. A replacement puppy of equal value will then be provided to the buyer, as soon as one becomes available. All shipping costs are the responsibility of the owner and not of Bravo Kennel. By signing this contract below, both parties agree to the conditions set forth above. In order for this health guarantee to be valid, the following conditions must be met: The new owner agrees that:

- 1) All pups are of sound mind and body and are stable temperment upon purchase of pup. Bravo Kennel is not responsible for the temperment of any pup after it leaves the premises.
- 2) All puppies must carry the (Bravo's) name on their registration and if advertised. No Bravo Kennel dog/bitch photographs, documents, files or titles will be used or advertised in any form or medium without written notorized permission from Bravo Kennel by the owner of this pup.
- 3) The dog/bitch must be registered with the FCI. And any future pups of said dog/bitch thereof.
- 4) **Pet quality Bravo Kennel Dogs/Bitches shall never be bred.**
- 5) The dog/bitch remains current on all vaccinations and dewormings, including all puppy shots recommended by a licensed veterinarian. The next vaccinations and deworming are due:_____. This guarantee is non-transferable.
- 6) No Bravo Kennel bitch shall be bred before her third heat cycle.
- 7) Bravo Kennel recommends the new owner will have their puppy professionally obedience trained.
- 8) The owner of this pup agrees to and gives Bravo Kennel permission to use and advertise any photos or documents in reference to this Bravo Kennel Pup.
- 9) This dog/bitch CANNOT be bred (including the sale of semen) without notorized written permission from Bravo Kennel.
